- Shall order his/her conduct so as to uphold the dignity, standing and reputation of the profession.
- Shall not undertake engineering work of a nature that his/her education, training and experience have not rendered him/her competent to perform.
- Shall certify to his/her employer or client, in writing, that he/she is competent to undertake and perform the particular engineering work for which he/she is to be employed or commissioned.

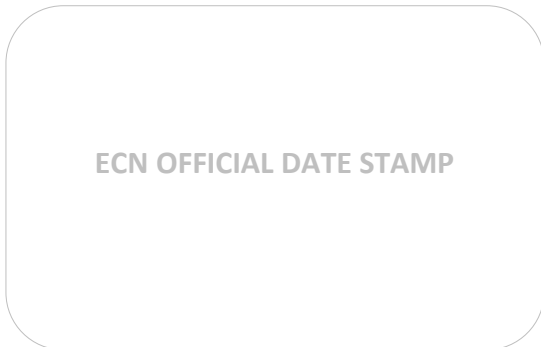
